member of Teaching Faculty
full-time employment

THE TASKS OF A PERSON EMPLOYED AT THIS POSITION WILL INCLUDE:

- conducting and documenting teaching activity, mainly practical classes, laboratory classes, etc.,
- participating in organizational work for the University and the Department (including participation in programmes related to the development of research and teaching level of the University commissioned by the Rector, Vice-Rector or Dean; care for the high quality of education and compliance with the internal principles of the education quality assurance system),
- improving teaching and other professional qualifications, including improving the knowledge of English, completing a course in academic teaching methodology, as well as participation in trainings and conferences,
- publishing and conference activities of teaching or popularizing nature (including popular science articles, reviews, etc.).

CANDIDATES MUST MEET THE FOLLOWING CONDITIONS:

- hold a Master's degree in physiotherapy,
- documented teaching experience at a higher educational institution or other educational institution **OR** documented research work **OR** documented work experience related to the prospective employment,
- a minimum of 3 years of teaching experience at a medical university, supported by professional successes and additional achievements,
- reliability, communication skills, proactive attitude.

WE OFFER:

- full-time employment contract as an academic teacher for an indefinite term,
- working at the best medical university in Poland, with the status of a research university,
- attractive employment benefits.

COMPETITION PROCEDURE:

- The competition may be entered by candidates who meet the requirements as stated in the art. 113 of the Act of Law on Higher Education and Science, such as:
 - meeting the requirements specified in the above mentioned Act and the Statute of the Medical University of Gdańsk (MUG),
 - not having been penalized with a disciplinary penalty specified in the art. 276 paragraph 1 points 7 and 8 of the above mentioned Act,
 - meeting the requirements specified in the art. 20 paragraph 1 points 1-3 of the above mentioned Act,
 - stating that, in case of winning this competition, the Medical University of Gdańsk will be the candidate's primary place of employment as defined by the above mentioned Act.
- Candidates willing to participate in the competition are asked to submit the application (all required documents) via the **APPLY** button.
- The deadline for applying is **23.07.2020 at 23:59** – the date and time recorded by the recruitment system is valid.
- The selected candidate will start work from **October 1, 2020**.
- The result of the competition is settled based on an analysis of the documentation submitted by the candidates.
- The result of the competition will be announced on the University website [RESULTS OF COMPETITIONS](#).
- The University reserves the right to close the competition without stating any reasons.

- The final decision about the employment of a candidate recommended by the Competition Committee is made by the Rector of the Medical University of Gdańsk.

REQUIRED DOCUMENTS:

- a written statement on entering the competition,
- personal questionnaire for a candidate applying for employment,
- CV (information on the candidate's previous work achievements),
- a university diploma stating the professional titles the candidate has earned (along with the supplement),
- professional specialization documents,
- copies of former employment certifications and a confirmation of current employment,
- other documents confirming qualifications and competencies for teaching students,
- the candidate's statement about meeting the requirements of the art. 13 of the Act of Law on Higher Education and Science,
- the candidate's statement that, in case of winning this competition, the Medical University of Gdańsk will be the candidate's primary place of employment as defined by the Act of Law on Higher Education and Science.
